Soft Touch Marine Rev Control for use with MSD 6M-2 Only PN 8768

Note: Read these instructions completely before attempting any installation.

Parts Included:

- 1 Soft Touch Marine Rev Control PN 8768
- 3 RPM Limit Modules (4,000, 6,000, 8,000 RPM)
- 1 Parts Bag with Mounting Screws

MOUNTING

The Soft Touch Marine Rev Control must be mounted close enough to the MSD 6M-2 Ignition Control to allow the matching Weathertight Connector to reach the Ignition Control. The Soft Touch can be mounted in the engine bay or driver's compartment. Do not mount the Soft Touch on the engine or near the exhaust manifold. Excessive heat must be avoided; install in a well ventilated area.

WIRING

Plug the 4-pin Weathertight Connector from the Soft Touch into the matching 4-pin connector on the MSD 6M-2 Ignition Control. The connector will only fit one way.

PROGRAMMING

The short Red and Blue wire loops coming out of the Soft Touch are used for programming the unit for 4, 6 or 8 cylinder operation. Modify the loops as described for the number of cylinders that your engine has.

8 cylinder: Do not cut any loops. 6 cylinder: Cut only the Red loop.

4 cylinder: Cut both the Red and Blue loops.

SETTING RPM LIMIT

The RPM Limit Module is sealed in a special Weathertight Connector which plugs into a matching 2-pin connector on the Soft Touch.

A. Plug the 2-pin RPM Limit Module into the matching 2-pin connector on the Soft Touch (Figure 1). Push until the positive lock produces an audible click indicating that the connector halves are completely joined.

B. If no RPM Limit Module is used, the RPM will not be limited by the Soft Touch. If additional RPM Limit Modules are desired, see the list of RPM Module Kits on the following page.


